DRIVER SAFETY COURSE

You may enter a plea of GUILTY or NOLO CONTENDERE and request a Driving Safety Course. You may lose that right if you do not provide written notice to the Court on or before your appearance date.

YOU MUST MEET THE FOLLOWING REQUIREMENTS FOR DSC:

- 1. You must possess a valid Texas driver's license or Active Duty Military ID.
2. You DO NOT hold a Commercial Driver's License (CDL).
3. You may take a DSC course for ticket dismissal one every 12 months.
4. DSC is NOT granted on school bus violations, construction zone with workers present, and speed violations of 25 over the posted speed.
5. You enter a plea of guilty or no contest and pay the fee of \$109.00.

You must provide proof of valid liability insurance, driver's license and fee with your DSC request. You will have 90 days (3 months) to complete your DSC class, return your Certificate of Completion and the required Certified Copy of your Driving Record (3a) to the Court. Only at this time your violation will be dismissed.

If you wish to enter a plea and waive appearance before the court and mail your fine(s), please indicate below in the proper space provided on the REPLY FORM.

- 1. I hereby enter a plea of GUILTY and waive appearance for trial. a CASHIERS CHECK OR MONEY ORDER in the amount of the Fine and fees enclosed.
2. I hereby enter a plea of NOLO CONTENDERE and waive appearance for trial. A CASHIERS CHECK OR MONEY ORDER in the amount of the fine and fees is enclosed.
3. I hereby enter a plea of () GUILTY or () NOLO CONTENDRE and request that I be allowed to take a Driving Safety Course for this violation as described above. I CERTIFY that I have not taken a course for a traffic violation within the past one (1) year and AM NOT IN THE PROCESS at this time elsewhere. The \$109.00 fee, a copy of my insurance & driver's license is enclosed.
4. I hereby enter a plea of NOT GUILTY and request a Pre-Trial Hearing.
